Abstract: Cipora O. Schwartz is a former Ridgewood resident and author who has had notable impact on the community's civic life. She served in key roles in various local advocacy organizations, most notably Citizens Park Association (CPA), Van Neste Park Restoration Committee, Ridgewood Association for Good Schools (R.A.G.S.), and Best in Education for Ridgewood (BRIDGE). Author of How to Run a School Board Campaign and Win (1982), she ran election campaigns for numerous Ridgewood Board of Education candidates and participated in the Democratic primary campaigns for U.S. Senate candidate Andy McGuire in 1977 and 1982. Also active in cultural life, Schwartz served as Production Manager of Young Ridgewood Sings, a non-profit program to augment music education for the Ridgewood schools and community. Other published writings include articles, pamphlets, and An American Jewish Odyssey: American Religious Freedom and the Nathan Barnert Memorial Temple (2007), a book-length history of Congregation B'nai Jeshurum, the oldest Jewish congregation in New Jersey of which she is a lifetime trustee. Schwartz's collected papers at the Bolger Heritage Center span from 1966 to 1996. The bulk of the collection consists of organizational records for the civic groups in which she was active, as well as records and materials related to the Ridgewood Board of Education campaigns she managed.

Cipora Odentz Schwartz was born in Tel Aviv, British Palestine Mandate (now Israel), on July 13, 1934. As a young child, her family moved to the small village of Chitre, Panama, where they lived until their immigration to the United States in 1946. Schwartz studied fine arts at Columbia University and would go on to further studies in political science and public administration. In 1949, she married Philip C. Schwartz from Paterson, New Jersey.

Scope and Content Note:

The collection measures 5 linear feet. The entire collection spans the years 1966 to 1996. The types of documents within the collection consist of manuscript notes, correspondence, meeting notes, meeting agendas, newsletters, program information, pamphlets, campaign materials, donor and contact lists newspaper clippings, blueprints, and photographs.

The collection has three (3) series: *Parks and Community Spaces Advocacy*; *Youth and Education Advocacy*; and *U.S. Senate Campaigns*. Within these three series are several subseries (see Arrangement Note below). The *Parks and Community Spaces Advocacy* series contains information relating to Cipora Schwartz's involvement in two local organizing efforts: the Citizens Park Association [CPA] and the Van Neste Park Restoration Committee. The *Youth and Education Advocacy* series contains information relating to Schwartz's work as a campaign consultant for school board candidates and to her involvement in three Ridgewood organizations: the Ridgewood Association for Good Schools (R.A.G.S.), Best in Education for Ridgewood (BRIDGE), and Young Ridgewood Sings. The *U.S. Senate Campaigns* series contains materials relating to her work supporting Andy Maguire's 1978 and 1982 campaigns for the U.S. Senate.

I. Parks and Community Spaces Advocacy, 1966-1996

Arrangement: Materials are arranged by topic or format. Within individual folders, materials are organized chronologically where date is known.

Summary: The materials in this series contain information on the Citizens Park Association (CPA) and the Van Neste Park Restoration Committee. The CPA was formed in 1968 by a group of residents seeking to expand public park land on the west side of Ridgewood. As the CPA's secretary and one of its core officers, Schwartz played an integral role in the organization's ultimate success at raising sufficient private funds to purchase from the West Side Presbyterian Church a 4.5 acre portion of the Kraft property at the intersection of Godwin Avenue and Monroe Street, which CPA then deeded to the Village to be used as a park in perpetuity. The CPA remained in existence even after achieving this primary goal and was involved in other efforts, including the restoration of Lester Stable (1976-1980). Decades following her CPA advocacy, Schwartz applied her fundraising expertise to the restoration and improvement of Van Neste Park by serving on the Van Neste Park Restoration Committee, an organization formed in 1990 by local residents in partnership with town merchants and village officials. The folders contain legal documents, organizational bylaws, plans, maps, blueprints, sketches, photographs, news clippings, published materials such as newsletters, event programs, and fundraising letters, and internal organizational records, such as correspondence, meeting minutes, member and donor lists.
